MATA will receive comments from the public for proposed changes to fixed-route bus service through 11:59 p.m. on Monday, September 14, 2020. Approved changes will become effective Sunday, November 8, 2020. These changes are recommended for the implementation of the new Transit Vision that was adopted by the MATA Board of Commissioners on January 29, 2019 to improve service, increase mobility and connectivity, and meet budget constraints.
